INDIVIDUAL PARTNERSHIP ACTION PLAN (IPAP) REPUBLIC OF MOLDOVA – NATO 2022-2023

PART I KEY POLICY AND REFORM OBJECTIVES OF THE REPUBLIC OF MOLDOVA

Chapter I POLITICAL AND SECURITY RELATED SUBJECTS

1.1. Cooperation with European and Euro-Atlantic structures and institutions

The Republic of Moldova is committed to further deepening cooperation with NATO, the main instrument of which is the Individual Partnership Action Plan (IPAP). In developing this IPAP, the national authorities took into account the practical measures for enhancing bilateral cooperation agreed by the Republic of Moldova and Allies.

The Republic of Moldova's main strategic objectives for development are political association and economic integration into the European Union by implementing the Association Agreement, as well as enhancing political dialogue and practical cooperation with the Euro-Atlantic structures.

Republic of Moldova – NATO cooperation is based on the respect for the Republic of Moldova's constitutional neutrality. As a neutral country, the Republic of Moldova does not pursue the implementation of this IPAP with the objective of gaining NATO membership. The national authorities intend to implement this Plan in order to advance the process of reformation and modernization of the national security and defence sector in accordance with the new developments and requirements of the current security environment, to develop appropriate capacities for addressing new challenges, and to strengthen the security of the Republic of Moldova and its citizens. To this end, the Republic of Moldova will make use of the legal and political basis, including relevant institutional mechanisms, which were set up during previous phases of IPAP implementation.

The Republic of Moldova is determined to develop close cooperation with NATO Allies and partners to counter new common security threats such as terrorism and cyber threats, which do not recognize national boundaries and are more various and complex, and to contribute to promoting stability and security in the region and on the European continent.

In the process of IPAP implementation, the authorities of the Republic of Moldova will conduct their activities in line with decision no. 14 of the Constitutional Court of the Republic of Moldova of May 2nd, 2017 regarding the interpretation of article 11 of the Constitution on the permanent neutrality of the country, which states that "the participation of the Republic of Moldova to the collective security systems, such as United Nations security system, peacekeeping operations, humanitarian operations, those which seek to impose collective sanctions against the aggressors and against those who violate the international law, does not contradict the neutrality status of the country".

The activity of the NATO Liaison Office (NLO) in the Republic of Moldova provides new possibilities to enhance the dialogue and practical cooperation in the process of reform implementation in the security and defence sector, implementation of assistance projects

as well as conducting public diplomacy activities. The national authorities will take actions to enhance cooperation with NLO in the areas of interest.

To develop security and defence capacities and to strengthen national security, the Republic of Moldova aims to capitalize on the cooperation possibilities provided by various NATO programmes, in particular the Partnership for Peace Planning and Review Process (PARP), Defence and Related Security Capacity Building Initiative (DCB), Building Integrity Programme (BI), Professional Development Programme (PDP), Science For Peace and Security Programme (SPS), Defence Education Enhancement Programme (DEEP) and Interoperability Platform (IP). While implementing the IPAP, the Republic of Moldova will cooperate with the EU and other international organizations to ensure complementarity of the IPAP with the Republic of Moldova-EU Association Agreement and the National Development Strategy.

1.2. Democratic reforms, human rights, rule of law, fight against corruption

The Republic of Moldova will continue cooperation with the Council of Europe, European Union, United Nations (High Commissioner for Human Rights, United Nations Office on Drugs and Crime), Organization for Security and Cooperation in Europe and Organization for Economic Cooperation and Development to promote democratic reforms aimed at strengthening the rule of law as well as adjusting national legislation and practices in the field of human rights, preventing and fighting corruption in line with relevant international standards.

The Republic of Moldova will continue undertaking efforts to comply with its obligations and commitments to the Council of Europe, through the implementation of related recommendations and resolutions adopted by the Committee of Ministers, Parliamentary Assembly and the Congress of the Local and Regional Authorities, included also in the Council of Europe's Action Plan for the Republic of Moldova, with the aim of concluding the monitoring process by the Parliamentary Assembly of the Council of Europe.

At the same time, the Republic of Moldova will cooperate with the Council of Europe and European Union in the implementation of programs aimed at adjusting national practices in line with European standards. To achieve that, national authorities will take concrete steps to approve and implement the Strategy for ensuring the independence and integrity in the justice sector for 2021-2024 and the Action plan on its implementation to ensure a set of principles and values that will govern the processes in the justice sector for the next period, increase institutional integrity climate by promoting zero tolerance to corruption, implementation of the National Action Plan on Human Rights for 2018-2022 and of the updated roadmap related to local and regional democracy in the Republic of Moldova, as well as other relevant actions will be taken. The new Council of Europe Plan of Action for the Republic of Moldova for the period 2021 - 2024, which is currently in the last drafting stage, will represent an important support instrument for adjusting national practices in line with European standards.

The Republic of Moldova will work closely with the Council of Europe and other international partners in order to enhance its efforts in the fight against corruption, including by implementation of the Council of Europe's Group of States against Corruption (GRECO) recommendations as well as by participating in the assessment process of the implementation of the United Nations Convention against Corruption.

An important subject of the Republic of Moldova - NATO dialogue is further developing cooperation within the Building Integrity Programme (BI). In addition to the DCB Initiative, BI will help the Republic of Moldova to strengthen the efficiency of its institutions in the security and defence sector by providing expertise and recommendations for the improvement of the financial and human resources management processes, strengthening of integrity, transparency and reduction of corruption risks in the security and defence sector.

The Republic of Moldova will strengthen its mechanisms for control of the exports of strategic and dual-use goods and will take further measures against money laundering, terrorism, organized crime and trafficking of human beings.

1.3. Territorial integrity and relations with neighbours

The Republic of Moldova stands for the peaceful, sustainable and comprehensive settlement of the Transnistrian conflict, within the framework of the "5+2" negotiation format, based on the sovereignty and territorial integrity of the Republic of Moldova within its internationally recognized borders, with a special status for the Transnistrian region.

At the same time, viable solutions for the issues included in all three baskets of the negotiation agenda must be identified and implemented. Equally, new development and confidence building projects need to be implemented, to support the Transnistrian settlement process.

The monitoring and protection of human rights in the Transnistrian region represents a constant priority and swift actions must be taken, including addressing individual cases of human rights violations by mobilizing the efforts of the actors of the "5 + 2" format and other international partners.

The securing of the central (Transnistrian) segment of the Republic of Moldova-Ukraine state border as well as the implementation of the joint control over this segment remain key measures to be carried out in cooperation with the Ukrainian government and with the active involvement of the EU Border Assistance Mission (EUBAM).

With reference to the political and military situation, the Republic of Moldova will continue to demand the immediate, unconditional, and complete withdrawal of Russian troops illegally stationing on the territory of the country, as well as the need for the transformation of the current peacekeeping operation into a multinational civilian mission under an international mandate. Maintaining stability in the Security Zone, democratization and demilitarization of the Transnistrian region, as well as the removal and destruction of ammunition stockpiles from the Cobasna storage will be ensured in a transparent manner, under OSCE auspices, and in cooperation with the relevant external partners.

The OSCE remains a key mediator in the "5+2" negotiation format in mediating the dialogue and related activities between Chisinau and Tiraspol through the existing platforms of interaction, contributing to efforts to address major impact on the interests of the people residing on the both banks of the Nistru River, implementing initiatives to bring closer the two banks, protecting the human rights in the Transnistrian region, efficiently managing the security aspects and facilitating the achievement of the final settlement of the Transnistrian conflict.

With reference to the relations with the neighboring countries, the Republic of Moldova develops multilateral cooperation with Romania based on common European values and the strategic partnership for the European integration of the Republic of Moldova. At the same time, the Republic of Moldova develops special relations with Ukraine.

In order to strengthen the regional stability and security, the Republic of Moldova will develop cooperation with other countries of the Eastern Partnership, the Regional Cooperation Council (RCC), the Organization for Economic Cooperation in the Black Sea (BSEC), the South-East European Cooperation Process (SEECP), the Organization for Democracy and Economic Development (GUAM), the Central European Initiative (CEI) and, in accordance with the Republic of Moldova's observer status, the South-East Europe Defence Ministerial (SEDM).

1.4. Security and defence sector reform

The Republic of Moldova is committed to the reform and modernization of the security and defence sector, aimed at enhancing its capacities and efficiency in mitigating risks and addressing threats to the national security. This objective implies harmonization and adjustment of the legal and policy framework governing the national security and defence system, as well as establishment of a single planning mechanism for the national defence.

Subsequently, the Republic of Moldova will continue implementation of the reform objectives set out by the national strategic documents, including the National Defence Strategy, Military Strategy and related action plans, as well as those deriving from commitments in the framework of cooperation programs, platforms, initiatives and projects. Special attention will be paid to the implementation of the Alliance's Wales and Warsaw Summit Decisions regarding the participation of the Republic of Moldova in the Defence and Security Related Capacity Building (DCB) Initiative and Interoperability Platform (IP).

The Republic of Moldova will strengthen national security through measures to enhance the professional development and expertise of officials and experts from the security and defence institutions, responsible for adjusting national policies and strategies, developing and implementing reforms, and modernizing national security capacities. To implement this objective, special emphasis is directed to developing cooperation with NATO within the Professional Development Programme (PDP) and Partnership Cooperation Menu (PCM).

Also, the Republic of Moldova will continue to promote gender policies within the national security and defence sector and to implement the collective United Nations Security Council resolutions on Women, Peace and Security (WPS).

1.5. Democratic control of the armed forces

The Republic of Moldova views democratic control of the armed forces as essential for a democratic society and an indispensable element of stability and security. Strengthening the role of democratic control of the armed forces will contribute to good governance, as well as to guaranteeing and ensuring the security, including military security, of the Republic of Moldova's citizens.

The Republic of Moldova builds viable capacities to guarantee the security and democratic development of the country, ensuring, for this purpose, the development of its

armed forces. Subsequently, necessary steps will be taken in order to enhance Parliament's role and the involvement of its specialized committees in overseeing the activities of institutions from the defence and security sector, strengthening the role of civilians in the decision-making process at all levels, implementing democratic standards in reorganization of the armed forces, promoting media and public access to defence and security matters, as well as engaging civil society in activities associated with drafting and promoting of the policies in the field of security and defence.

1.6. Combating terrorism

In line with international norms and its commitments, the Republic of Moldova will further implement the programs and strategies to combat terrorism, enhance the cooperation and coordination between its national institutions and develop partnerships with NATO Allies and partners in this regard.

1.7 Cyber defence

The Republic of Moldova will undertake further efforts to strengthen institutional capabilities in cyber defence and protection of strategic communication and information systems against cyber-attacks. To this end, the Republic of Moldova is interested in developing cooperation with NATO and Allies on enhancing the resilience of its critical infrastructure to cyber threats.

1.8 Sustainable economic development and energy security

With the view of promoting sustainable development, the Republic of Moldova will continue to implement the provisions of the National Development Strategy, Government's Programme of Actions, Sustainable Development Goals, Moldova-EU Association Agreement as well as those of other national and sectorial strategic planning documents. The national authorities will undertake measures to continuously improve the business environment and strengthen cooperation with international financial institutions. Further actions will be taken to enhance economic development and energy security, including through the expansion of energy transportation and distribution networks, modernization of generating capacity, promoting energy efficiency and the use of renewable energy sources.

Chapter II DEFENCE AND MILITARY ISSUES REFORM OF THE DEFENCE AND SECURITY SECTOR

2.1. Defence sector reform. Strengthening the defence capacity of the state

The Republic of Moldova will continue the reform and modernization process of the national defence and security system, strengthening the national defence capacity aimed at preventing, managing and countering threats and risks to the security of the state.

The Republic of Moldova will continue to implement reform objectives set out in the national strategic documents drafted with the support of international experts and approved in the Phase I of the NATO Defence Capacity Building (DCB) Package for Moldova, as well as those deriving from the commitments undertaken in the framework of various cooperation programs, platforms, initiatives and projects. Particular attention

will be attached to the implementation of the PARP Partnership Goals, Phase II of the DCB package, and the objectives of the Interoperability Platform. The Republic of Moldova is determined to implement ongoing development projects and bilateral programs as well as to initiate new ones in support of the transformation efforts of the country's defence capabilities.

The reform of the defence system begins with the establishment and development of a mechanism for national defence planning and decision-making, as well as its correlation to the medium-term budget planning mechanism according to the provisions of the Law on public finances and budgetary-fiscal responsibility no. 181/2014. In this respect, the aim is to exchange experiences and consult with international experts in order to adopt best practices on development and use of effective strategic planning tools. Thus, the Republic of Moldova will strengthen its efforts on developing doctrine documents, methodological instruments and decision-making mechanisms in line with the international standards applicable to the field of defence.

In the current security context, strengthening and developing military capabilities is imperative for the Republic of Moldova. The efficient transformation of the National Army is planned to take place within a period of 11 years, in accordance with the lines of effort, objectives and actions required to develop the military capabilities set out in the long term military capability development plan (2020-2030).

Thereby, the Republic of Moldova will direct its efforts towards the development of the long-term military capabilities linked with the assistance programs and projects, ensuring an increased degree of reaction and mobility of the National Army's forces and means.

At the same time, measures will be taken for the development of command, control, combat and logistic support systems, airspace control capability, modernization of training centers, and maintenance and modernization of military equipment, armaments and ammunition. Also, special attention will be directed to improving and developing personnel and defence resources management processes, including through cooperation with the NATO Building Integrity (BI) Programme. The Republic of Moldova stands ready to continue the implementation of activities in the framework of projects, initiatives and trust funds aimed at contributing to the development of defence capabilities, including in the framework of the PARP.

2.2. Development of education, training and scientific research in the field of defence and security

The Republic of Moldova pays special attention to higher education and specialized training, including through enhancing partnerships as well as implementation of joint projects. The main effort consists of developing military education qualified to train skilled leaders and experts, developing educational infrastructure, training and scientific research to fill the requirements of the national defence system, as well as achieving a competitive and efficient military education system adapted to the developments in the military field and the dynamic of the global security environment. In this regard, the aim is to develop the professional capacities of the civilian officials in the security and defence sector through the NATO Professional Development Program (PDP).

Special attention will be given to the improvement and development of the education and training system at all levels in the field of defence and military science to develop an effective and inclusive defence system. The Republic of Moldova will continue its efforts

and will engage in the field of military education through the Defence Education Enhancement Programme (DEEP).

The Republic of Moldova will continue cooperation for the development of its educational system in the field of defence and military sciences. In order to ensure the sustainable development of its scientific and technical capacity, the Republic of Moldova is engaged in a practical dialogue with NATO in the following priority areas of scientific cooperation: cyber defence, implementation of UNSCRs on WPS, and developing capabilities for the mitigation of risks associated to chemical and biological agents in the Republic of Moldova.

The Republic of Moldova will continue to implement measures to strengthen the integrity of the defence and security sector through the Building Integrity (BI) Programme.

Strengthening cyber defence will be achieved in part by the implementation of the project on establishment of the Moldovan Armed Forces Cyber Incident Response Center (MAFCIRC) and a training and testing laboratory with cyber defence capabilities within the Ministry of Defence in the framework of the DCB Initiative.

2.3. Increasing the level of interoperability

Achieving a high degree of military interoperability and cohesion with NATO Allies and partners is key to increasing the level of the participation of the Republic of Moldova in NATO activities, as well as to its contribution towards strengthening and maintaining stability in the region and globally.

These ambitions will be achieved through continued participation in the PARP process, which provides a structured approach for enhancing interoperability and capabilities, through participation in national and international military exercises, and by developing and applying international and NATO standards within the armed forces. In this context, efforts will be undertaken to train forces capable of operating alongside the forces of partners in multinational humanitarian and peacekeeping operations.

Building capacity and contributing to regional and international security continues to stand as an important objective of the Republic of Moldova. In this respect, the aim is to intensify political-military dialogue with international structures and institutions to strengthen cooperation with external partners and capitalize on the opportunities to increase the participation of the Republic of Moldova in international missions and operations under the UN mandate.

At the same time, the Republic of Moldova tends to maintain and develop training capabilities of the personnel intended to participate in international missions and operations in line with the standards of the international organizations with competencies to ensure interoperability and effective cooperation with the similar structures.

The Republic of Moldova will maintain its commitment to strengthening and promoting security and stability in Europe by participating in the KFOR NATO-led international peacekeeping force in Kosovo under the UN mandate.

2.4. Strategic Reform of the Border Police

As a part of a comprehensive reform process of the defence and security sector, this objective seeks to develop the system of border security coordination in alignment with the European border surveillance system, as well as enhance technical and infrastructure capacity of the Border Police. At the same time, there is interest to develop cooperation and information exchange with NATO Allies.

2.5. Reform of the Carabineer Troops

The Republic of Moldova views strengthening the capacities of the General Inspectorate of Carabinieri as an important element of a comprehensive security and defence sector reform. In this regard, required measures will be taken towards improvement of the operational capabilities of the General Inspectorate of Carabinieri for peacetime and crisis missions, including peacekeeping operations.

Chapter III INFORMING THE PUBLIC, COOPERATION IN THE SCIENTIFIC AREA AND MANAGEMENT OF CRISIS SITUATIONS

3.1. Public diplomacy on security and defence related matters

The Republic of Moldova will undertake necessary measures to inform the citizens of the country in a broad and accurate manner on security and defence related subjects, such as: developments in the European and international security environment, new challenges and threats, the need and importance of implemented reforms in the security and defence area, and policies and measures to strengthen the security of the citizens and of the state. National authorities will promote Republic of Moldova-NATO cooperation in Moldovan media, and will communicate proactively about the objectives, results and benefits of both the political dialogue and practical cooperation between the Republic of Moldova and NATO, highlighting the benefits for the citizens of the Republic of Moldova. The end goal is to increase understanding and support of the citizens and civil society for the aforementioned subjects and to strengthen resilience of the public in face of disinformation. Providing information about the security and defence policies of the neutral and non-aligned countries from Western Europe and their cooperation with NATO will continue.

Developing strategic communication capacities within national institutions constitutes a priority for the Republic of Moldova. Strategic communication represents one of the tools available to the state for achieving its objectives in the security and defence sector. The efficient use of strategic communication by the national authorities represents an important capacity that the Republic of Moldova has yet to develop. Achieving this objective foresees undertaking efforts aimed at learning and applying the experience of the development partners in determining the necessary capacities, the efficient mechanisms of strategic communication as well as ways of interaction and coordination among all public authorities. The Republic of Moldova is interested in developing cooperation with NATO and exploring existing mechanisms aimed at enhancing strategic communication at the national level. As part of these processes, national authorities will seek to further develop cooperation with the NATO Strategic Communication Centre of Excellence from Riga.

The authorities of the Republic of Moldova will cooperate with the NATO Liaison Office in the Republic of Moldova and the Information and Documentation Centre on NATO in Chisinau in order to continue media capacity building, disseminate relevant information, and along with the NATO Public Diplomacy Division, organize common activities in this regard. National authorities will continue to engage with the NATO Contact Point Embassy in Chisinau in these efforts.

In order to demonstrate the practical results, advantages and benefits of the Republic of Moldova - NATO cooperation in an objective and compelling manner, national authorities will present the outcomes of projects implemented within the Science for Peace and Security (SPS) Programme, NATO Trust Funds and other NATO partnership programmes.

3.2. Cooperation in the scientific area, including in the framework of Science for Peace and Security Programme

The Republic of Moldova seeks to guarantee sustainable development of its scientific and technical capacities to enhance national resilience and to face modern challenges and security threats.

In this regard, special attention will be attached to enhancing cooperation within the Science for Peace and Security (SPS) Programme on matters of mutual interest, including by implementation of the new projects. Priority areas for scientific cooperation are: human and social aspects of security, cyber defence, environmental security, counter-terrorism, energy security, and conducting regional studies.

The Republic of Moldova will continue the implementation of the SPS flagship activities, including the project on "Moldovan Armed Forces Cyber Incident Response Capability (MAFCIRC)" and the project on developing the capabilities to mitigate the risks of biological agents.

3.3. Crisis management, preparedness and planning capabilities for emergency situations

The Republic of Moldova aims to develop institutional capacities to strengthen national resilience to new challenges across the seven Baseline Requirements¹, enhance its preparedness and response system to civil emergency situations, and strengthen its management capacities during a crisis. To achieve that, the Republic of Moldova is interested in developing cooperation and information exchange with NATO in areas such as whole-of-government approach to security and defence, early warning, implementation of best practices and lessons-learned related to preparedness and response to civil emergency situations, consultations, trainings and exercises in crisis management.

Chapter IV ADMINISTRATIVE ASPECTS, PROTECTION OF INFORMATION

4.1. Administrative aspects

The Individual Partnership Action Plan will be implemented by the national authorities with relevant competences and responsibilities, as mentioned in this document. The Ministry of Foreign Affairs and European Integration will coordinate further the IPAP

implementation process and will inform, annually, the Government, the Parliament and the President of the Republic of Moldova on its implementation.

The Republic of Moldova will ensure the implementation of the provisions of the Agreement on the establishment of the NATO Liaison Office in the Republic of Moldova and will cooperate with the Office in the process of IPAP's implementation.

4.2. Protection of classified information

The Republic of Moldova will ensure full implementation of the Security Agreement between the Government of the Republic of Moldova and NATO and will continue to strengthen its relevant national system. The details pertaining to the procedures and minimum requirements for the protection of classified information will be specified in the Administrative Arrangements to be agreed between the Republic of Moldova and NATO.
